2. **Raskot Municipality** invites electronic bids from eligible bidders for Procurement of construction of 15 bedded hospital Building, **Raskot-5, Kalikot** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **Nrs. 106800000.00 ( in words: ten crore and sixty eight lakh only)**
  - Minimum Work experience of similar size and nature: **Nrs.114000000.00 (in words: Eleven crore and forty lakh only)**
3.   4. Bidder has to submit their bid electronically only and may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).. Bidders should deposit the cost of Rs. 10000.00 (in words: ten thousands rupee only) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 2078/02/06 at 12 noon Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2.0 P.M. on 2078/02/06 at the office of Raskot Municipality. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a scanned copy of bid security in pdf format amounting to a minimum of **Nrs. 4000000.00 (in words: Forty lakh only)** shall be valid for 30 days beyond the validity period of the bid .
7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. All the right whether to accept or reject the bid partially and fully are reserved to Raskot Municipality,Kalikot.
